## Get started with compliance

Before looking ahead to shipping products, it's important to ensure your business meets applicable regulatory requirements. Compliance with those requirements ensures that your products will be:

- · efficiently exported from Australia
- · imported into the destination market without delay, and
- · lawfully sold in the destination market.

Before registering your products and applying for an export licence and approval, you'll need:

- · Label Integrity Program records (vintage, variety, origin)
- · Product analysis details
- · Accurate records to meet compliance obligations
- An understanding of the regulatory requirements of the destination market (including regarding duties and taxes, and those which apply to labelling, permitted and prohibited winemaking practices, and importation certificates and procedures).

To get your products to market, use WALAS to:

- · Apply for export permits and documentation
- · Track submissions in real-time
- · Access WALAS training modules and Quick Reference Guides
- Learn about the Label Directory which allows brand owners to identify potential breaches of intellectual property rights and provides a platform through which consumers can verify whether a label has originated in Australia

## Use data to inform your decisions

Reliable data is a powerful tool. From historical export performance and trends to identifying growth markets, these resources can help you plan and make informed, commercially sound decisions.

#### **Export Dashboard**

The export dashboard provides interactive and comprehensive data and insights on Australian wine exports back to 2010. It provides headline figures for the latest release of data, and detailed statistics on wine exports by destination market, Gl claim, variety, wine style, container type and exporter size.

#### **Market Explorer**

Market Explorer assists levy payers who want to export Australian wine or seek to explore new markets and need data to inform decisions.

It can help determine which market is the most attractive to an Australian wine business by showing where wine is consumed and how much, which markets are showing growth in wine consumption, the share of on-trade versus off-trade, and what share of that consumption is Australian wine.

Please note: the Market Explorer is only accessible to Australian wine levy-payers and exporters. Make sure you are logged into your levy-payer-access website account.

#### **FOB to Retail Calculator**

The FOB to Retail Calculator allows users to calculate what the bottle price will be on shelf (the RRP) in international markets for a given FOB value, and assess and evaluate competitors in market through price point comparison.

#### **Quarterly Export Reports**

Get the latest insights into Australian wine export performance and trends in key markets and regions. Go to wineaustralia.com/ market-insights/australian-wine-exports.

#### **Australian Wine Export Monitor**

A one-page, high-level, historical summary of the total exports of Australian wine. It includes both the value and volume of export sales broken down by wine style and container type, plus the percentage change year-on-year over the past 10 financial or calendar years.
